

HOW TO READ YOUR UTILITY BILL

- 1) **ACCOUNT** – Your account number identifies you and your property address in our customer billing system. Please use this number whenever you contact us with question about your account or if you make online payments through your bank. If you had an account with us prior to April of 2011 your account number has changed as of the April 2011 billing; make sure you update your account number if you pay your bills via online through your bank. Account numbers had to change due to the implementation of new utility billing software and to improve security. We will be implementing online services in the future and changing account numbers will make it less likely someone could figure out your account number.
- 2) **SERVICE ADDRESS** – This is address where utility service is being provided. It may or may not be the same as your billing address.
- 3) **SERVICE PERIOD** – This is the period of service for the current bill.
- 4) **DUE DATE** – Your payment should be received by the City of Newman on or before the date shown. Water services may be discontinued for a lack of payment. Any bill not paid by the due date may be subject to late payment charges. The City of Newman is not responsible for any payment which may be in transit on the due date.
- 5) **BILLING ADDRESS** – This is where your utility bill will be mailed. This may or may not be the same as the Service Address.
- 6) **METER READING** – This section contains your prior month and current month meter reading and meter reading dates. The difference between the two meter readings is your consumption (Cons). The Usage History graph (#11 in the middle of the bill) plots your consumption over a two year period.
- 7) **CURRENT CHARGES** - These are the charges for service since your prior billing period.
- 8) **TOTAL CURRENT CHARGES** - This is the total of your current period charges.
- 9) **BILL SUMMARY** – This section includes your prior balance, any payments since your last bill, adjustments, additional billing and your current charges from the section immediately above it.
- 10) **TOTAL AMOUNT DUE** – This amount takes your prior billing balance, subtracts any payments since your last bill, includes any adjustments or additional billing and adds the current charges to arrive at your total amount due.
- 11) **USAGE HISTORY** – Graphically displays your prior and current years consumption (Cons). Blue is your prior year, yellow is your current year.
- 12) **SPECIAL MESSAGE** – Notices and other city related messages will be located in this section.

The bottom portion of your bill should be detached and returned with your payment. This stub includes your account number, due date and amount due.
