Open to households Fridays & Saturdays 8AM to 12PM from September through May NEW SUMMER HOURS: Fridays & Saturdays 7:30AM to 11:30AM from June through August

- 15 gallon limit. You may only bring up to 15 gallons (or 125 pounds) of waste per day. We will not accept anything over this limit. No container larger than 5 gal. (H&SC 25218.5.1)
- Do not leave hazardous materials at the Household Hazardous Waste Collection Facility before hours, after hours, or when an operator is not present.



- -Button batteries must be taped

- Paint/Paint Thinner (new & used)

- Pool/Spa Chemicals

UNACCEPTABLE HAZARDOUS WASTE

The following wastes will not be accepted at the facility or temporary events

- No Ammunition
- No Asbestos
- No Business Waste
- No Container larger than 5 gal.
- No Commercial AG Chemicals
- · No Cooking Oil
- No Dried Paint
- No Empty Containers
- No Explosives/Ammo
- No Hard Concrete
- No Loads over 125lbs
- No Out of County Waste
- No Pharmaceutical Waste
- No Propane Cylinders larger than 5 gal.
- No Welding/Oxygen, Helium etc. Pressurized Gas Cylinders
- No Radioactive Waste
- No Tires



Sharps Waste

Home-Generated Sharps Accepted

- Only home generated used sharps will be accepted (no businesses)
- Used sharps must be stored in a rigid container with a closed lid
- Containers must be rigid plastic, sealed, leak proof, and cannot be easily reopened
- No glass or cardboard containers will be accepted
- Examples of acceptable containers include: empty soda bottles, coffee cans, juice bottles, laundry bottles etc.
- Do not mix medications with sharps

Some companies sell containers, and provide mail back service for sharps.
